

#### This Condition Report is required to be completed prior to confirmation of the Minister's placement.

#### What the Responsible Body has to do

Before the Minister moves into the Manse, the Responsible Body must:

- 1. Complete the Responsible Body section of the Condition Report.
- 2. Sign and date the Condition Report.
- 3. Photocopy the Condition Report for your records before giving it to the Minister.
- 4. Give the Condition Report to the Minister to complete.
- 5. Agree on a date for the Minister to return the completed Condition Report to you.
- 6. Give a copy of the Condition Report to the Presbytery after you and the Minister have completed it.
- 7. Complete the Exit Report at the end of the occupancy.

#### What the Minister has to do

- 1. Complete and sign the Condition Report and any attachments and return it to the Responsible Body by the date agreed between you and the Responsible Body.
- 2. Inspect the Manse premises and complete the Minister section of the Condition Report.
- 3. Make a comment where you disagree with the Responsible Body's description of an item.
- 4. Sign and date the Condition Report.
- 5. Photocopy the Condition Report for your records before returning it to the Responsible Body.

#### What the Presbytery has to do

- 1. Inspect the manse premises and check that the Responsible Body and the Minister have completed the Condition Report correctly.
- 2. Note any comments in the Presbytery Comments section at the end of the Condition Report.
- 3. Sign and date the Condition Report.
- 4. Photocopy the Condition Report for your records and give a copy to the Responsible Body.

#### Important information for Responsible Body and Minister

- This Condition Report is an important written record of the condition of the Manse premises. Both the Responsible Body and the Minister should keep signed copies for future reference. It may be used as evidence in any dispute about cleaning, damage, safety or missing items. It is vital that you complete the report comprehensively and note anything which seems unsafe or insecurely fixed.
- If you do not have enough space to list all items you want covered in this report, attach a separate sheet.
- For properties with more than one Bathroom or Bedroom, please complete a separate form for each of these.
- All attachments should be signed and dated by both the Responsible Body and the Minister to show that both parties
  have read and agree to any future reference.
